IMPORTANT INFORMATION

On the following pages you will find a registration form, and a decline insurance form. When filling them out please print legibly **IN ALL CAPITAL LETTERS** and include all information requested. All correspondence about the cruise is via email, thus an email address is required.

Travel insurance: you may purchase travel insurance from me, or from any reputable carrier, however, is particularly important that should you decline to purchase the optional insurance from me, you **MUST** include a signed 'Decline Insurance' form or your registration will not be processed.

The final payment deadline is April 1, 2018. Bookings may be made after this date but are subject to availability.

Airfare can be arranged for the cruise via Holland America at the time of your cruise booking, rates are subject to your departure airport. You may also choose to book your airfare through any online site, which will be less expensive than booking through HAL. Please remember any quoted airfare from Holland America is subject to change at ANY TIME until the booking is paid in full.

Once you have been registered, you are responsible for any and all penalties regardless of the reason of withdrawal from the program. Insurance is highly recommended. Final payment invoices are e-mailed about one month before the final payment is due, please update us should your email address change.

Workshop selection information will be emailed in March, 2018. Please be sure we have a current email address on file for you.

Visa Information for Russia

Cruise ship passengers can currently visit Russia on visa-waiver scheme provided the stop in the port of call doesn't exceed 72 hours and tourists stay overnight on board the cruise ship. However, cruise passengers may disembark from the ship without a tourist visa ONLY if they participate on tours organized by Holland America. Passengers not participating on Holland America tours and wishing to disembark will need to obtain a Russia tourist visa. Passengers won't be permitted ashore if they don't present a valid passport, a Russian visa and a voucher issued by a Russian travel company or another authorized organization.

Cruise passengers cannot obtain a visa in Russia. Visas must be issued in the country of residence before departure.

Please note – availability and pricing cannot be confirmed until your booking is received and booked with the cruise line as cabins are selling quickly.

For those who would like to pay by check or money order, you receive the cash discounted price below. For Paypal/Credit Cards, we cannot give the cash discount our regular rate (without the discount) is approximately 3% more.
