**IMPORTANT INFORMATION**

On the following pages you will find a registration form, and a decline insurance form. When filling them out please print legibly and include all information requested.

For travel insurance, fees will be dependent upon several things, for example what cabin category you choose. Upon request I will quote you insurance rates based upon your travel selections. You may purchase travel insurance from me or from any reputable carrier, however, is particularly important that should you decline to purchase any insurance protection you **MUST** include a signed 'Decline Insurance' form or your registration will not be processed.

Please be certain that you read and understand the terms and conditions found online as indicated by the link from the tour website.

Register by December 1 to insure space on the cruise. The final payment deadline is, without exception December 20, 2012. **Registrations will still be accepted after this date, then however, full payment is due at time of registration.** If final payment is not made by this time, penalties will be incurred and there will be no refunds. Once you have been registered, you are responsible for any and all cruise line penalties regardless of the reason of withdrawal from the program. The penalty phase begins with the final payment deadline. Insurance is highly recommended.

Transfers from the airport to the ship are not offered as it is more economical for 2 people to take a taxi.

Please register early as spaces cannot be guaranteed, cabins are selling fast. Some categories are already sold out.

Please do not book airfare until you are informed that the cruise is a go. Considering NCL air? Please be aware that it is often less expensive to book your airfare independently.

When returning your forms, please be certain that you have:

1. Enclosed a check for the Cruise Deposit of \$500 per person. Canadian payments must be in the form money or or cashier's check, or drawn on a US bank.
2. Signed all applicable forms where indicated.
3. Indicate insurance choice and included the decline insurance form if appropriate.
