IMPORTANT INFORMATION

On the following pages you will find a registration form, and a decline insurance form. When filling them out please print legibly and include all information requested.

For travel insurance, again, fees will be dependent upon several things, whether you choose the cruise only or the option in Birmingham, cruise category, airfare, etc. Upon request I will quote you insurance rates based upon your travel selections. You may purchase travel insurance from me, or from any reputable carrier, however, is particularly important that should you decline to purchase the optional insurance you **MUST** include a signed 'Decline Insurance' form or your registration will not be processed.

Please be certain that you understand the terms and conditions found online as indicated by the link from the tour website regarding penalties and refunds. The final payment deadline is, without exception June 1, 2009. Registrations will still be accepted after this date however, full payment is due at time of registration. Please register early as spaces cannot be guaranteed.

Airfare can be arranged for the cruise only portion through Princess at the time of your cruise booking, rates are subject to your departure airport. Airfare can also be purchased at any time through any agent or online site, however to participate in quilting activities of this cruise, bookings must be made through Deb Roberts Tours, a registered seller of travel in the State of California and participant in the Travel Consumer Restitution Fund.

Refunds for the cruise only portion of the tour are available if written notice of cancellation is received by Deb Roberts before the final payment deadline of June 1, 2009. \$100 of the deposit is not refundable. There can be no refunds on the optional tour to the Festival of Quilts. If final payment is not made by this time, penalties will be incurred and there will be no refunds. Once you have been registered, you are responsible for any and all penalties regardless of the reason of withdrawal from the program. Insurance is highly recommended.

When returning your forms, please be certain that you have:

1. Indicated your choice for the fundraising donation.
2. Enclosed a check for the Cruise Deposit of \$600 per person.
3. If applicable, an optional tour deposit of \$100 per person
4. Signed all applicable forms where indicated.
5. Indicate insurance choice and included the decline insurance form if appropriate.

Final payment is due on or before June 1, 2009 without exception, or I am subject to a late fee of 5% and/or loss of space.

I am responsible to purchase air either on my own or from Princess should I select the cruise only option. By submitting this registration form, I understand and agree that Deborah Roberts is acting as an independent organizer of this tour and as such she is not responsible or liable for the willful or negligent acts and/or omissions of a tour company, cruise line, tour director, hotels, contractors, or any air carrier, their employees, agents, servants, or representatives including, their failure to deliver or their partial or inadequate delivery of travel services.
