It is particularly important that should you decline the optional insurance, for any reason, you **MUST** include a signed 'Decline Insurance' form or your registration will not be processed. I feel that travel insurance protection is particularly valuable, and is not just cancellation insurance, but covers medical needs, unexpected departure for emergencies at home, etc. Insurance, if purchased, is not in effect until final payment has been made.

Should someone register after this date, full payment is due at time of registration and space/prices are subject to remaining availability. Please register early as spaces cannot be guaranteed.
